Sub: Information regarding acceptance charges of MMSC, Analysis Charges & Membership Security Deposit of CHW-TSDF-Pithampur for industries of MP state.

Ref: MPPCB Letter number 2615/PCB/UPTO/22/Bhopal dated 16/06/2022 & MPPCB letter no-3429/Tech/PCB/2022, dated 20th September 2022.

Respected Sir,

With reference to referred letters and meeting held with Chairman MPPCB & Executive Director, MPIDC Limited, Indore & MD, Pithampur Auto Cluster at MPPCB head office Bhopal on 19th September 2022 on subject matter, all concerned industries are hereby informed that following points were discussed & rates are agreed for implantation to industries of MP state with effect from 1st October 2022 as under:

- 1. Minimum Monthly Service Charges (MMSC) has been stopped and it will not be charged from any member industries of CHW-TSDF Pithampur, Dist. Dhar (MP).
- 2. Repeat / re-analysis of same hazardous waste samples in every two years has been waived off for small scale industries (SSI), however SSI units has to produce declaration to CHW-TSDF-Pithampur stating that "No change of raw materials, process, product, by product, operating parameters".
- 3. Comprehensive analysis of hazardous waste sample has been fixed @Rs.12,000/- per sample (excluding Taxes) to all type of industries for financial year 2022-23 in place of Rs.15000/- which were charged earlier.

- 4. Membership security deposit has been fixed Rs.5000/- instead of earlier charge Rs.20,000/- for small scale industries (SSI). Membership Security Deposit for large & medium scale industries will be charged maximum to equivalent of estimated total disposal cost (inclusive all) of all type of hazardous waste generated in one month. Disposal invoice will be submitted to industries 25th of every month through email/ whatsup. Industries shall have to make the payment within 2-week time.
- 5. Transportation rate has been discussed and explained @ Rs.4.75/ MT/KM to regular waste generator in case of general condition. However, waste generators are free to send hazardous waste through other MPPCB authorized transporter.

Above revised service charges will be in force with effect from 1st October 2022 onwards to waste generators / industries of CHW-TSDF Pithampur.
